# MESSAGE FROM CHANTELLE JOHNSON & BLAINE BEAVEN

Reflective practice is part of CLASSIC's culture. We continue to reflect on how COVID-19 and social policy decisions impact the community CLASSIC serves. This year was a transition into a more 'normal' existence. Unfortunately, 'normal' for many of our community members consists of houselessness and despair.

The Saskatchewan Income Support (SIS) program continues to present significant challenges to the communities CLASSIC serves. Individuals and families continue to fall through the cracks and experience increased hardship due to inadequate access to income support. Coupled with the lack of affordable, quality housing, this has created extreme distress for many of our clients. CLASSIC spent more time this year than ever before, through our legal and community support programs, assisting folks impacted by this reality.

Compounding these challenges, CLASSIC, like many other organizations, faced difficulties maintaining, obtaining and accessing crucial funding required to address the growing demand for its services within the community. Timely and predictable funding is crucial for organizations to fulfill their missions and effectively serve their communities. Unfortunately, CLASSIC faced two significant issues in this regard. CLASSIC's incoming funding for the 2022-23 fiscal year did not keep pace with the rising costs of operations due to inflation. Other critical funding commitments were received significantly late in the fiscal year, resulting in CLASSIC navigating much of the year with limited resources. Ultimately, these challenges resulted in CLASSIC scaling back essential staff positions.

Despite this reality, CLASSIC continued to work meet the needs of our clients, students, and community this year. As CLASSIC moves forward, we are committed to focusing on Priority and Objective 2a) of our Strategic Plan which is to work toward being able to plan long-term operationally and financially at CLASSIC.

## **SNAPSHOT OF 2022/2023**

- CLASSIC resumed hosting Intensive Clinical Law students. This was the second year of a three-year
  Memorandum of Agreement between CLASSIC and the College of Law. We continued our pilot project
  of a reimagined student model to better lend CLASSIC's mission, vision, values, and priorities.
  Preliminary reflections are positive.
- As travel opened up, the demand for CLASSIC's immigration and refugee services skyrocketed.
   CLASSIC is the only free, full representation legal service provider for immigration and refugee matters in Saskatchewan. CLASSIC worked on 230 immigration and refugee files this year.
- Our work has gotten more complex. Many people need systems navigators to assist them to use technology they do not have access to. These systems changes have off-loaded responsibility to nonprofits such as CLASSIC. We provide computer, phone, and other tech resources to people with our legal services. We need more resources to meet our values which are to be professional, transformative, resilient and client-centred. Our community needs allies now, more than ever.

CLASSIC welcomed Intensive Clinical Law Students for the 2022 Fall term and the 2023 Winter term. We continued to pilot a redesigned student model developed in the previous year. Our goal through the pilot project is to provide a program to better lend to our vision, mission, values and priorities. We used lessons learned from the pandemic and our staff-only operations, to create a new clinical experience coupled with articling students. We will continue to test the redesigned student model next academic year during the last year of our current contract with the College of Law, University of Saskatchewan.



## WALK-IN ADVOCACY CLINIC (WAC)

CLASSIC's Walk-in Advocacy Clinic (WAC) provides full legal representation to people who experience poverty and injustice in approximately 20 areas of law. This program works in tandem with the Student Training and Education Program (STEP) with students working on assigned client files under the direct supervision of staff lawyers. Of the 926 client files CLASSIC assisted with in 2022 - 2023, 737 files was in our top 6 areas of law, while the remaining 189 files were in other areas as demonstrated below.




# LEGAL ADVICE CLINIC (LAC)

CLASSIC's Legal Advice Clinic (LAC) works in partnership with Pro Bono Law Saskatchewan (PBLS) to provide unrepresented or self-represented individuals with free summary legal advice from practicing lawyers in the areas of criminal, family, immigration and civil law.

This clinic is for people:

- · who experience poverty,
- do not qualify for full-representation legal services through CLASSIC's Walk-in Advocacy Clinic,
- do not qualify for Legal Aid services, and
- · cannot afford to retain a private lawyer.



## COMMUNITY SUPPORT WORK (CSW)




## **Systems Navigation**

The systems navigation provided by CLASSIC Community Support Worker (CSW) involves:

- helping clients through increasingly complicated and complex systems,
- · ensuring people are treated with dignity,
- · advocating for peoples' rights, and
- ensuring people do not completely give up on these systems.

Increasingly, more non-profits need to hire systems navigator roles to walk with people through these systems.





#### **Crisis Triage**


One of the trends over the last year were individuals with 'one-time' access to services. About 30% of the people who work with the CSW come just 1 - 2 times when in crisis. The CSW assisted them with their urgent need and that concluded work with them.

Just over half the people the CSW works with are on an intensive to semi-intensive basis. Interactions range from high crisis to more general check-ins. Often, the CSW walks with people as they navigate complex systems and emotions in their daily life. One of the largest crisis-based needs is housing and the complete lack of options to fill this need.

Another trend for in individuals accessing services is the increase in psychosis related symptoms. An increasing amount of people walk through CLASSIC's door exhibiting signs of delusions and/or hallucinations.

## **ADDRESSING SYSTEMIC BARRIERS**

CLASSIC arose from a systemic realization that people who experience poverty and injustice did not have many supports in Saskatchewan. CLASSIC's mere existence is a systemic response to a societal shortcoming. CLASSIC's values of being professional, transformative, client-centred, and resilient inform how we deliver our services. Our goal through full legal representation, summary advice, community supports, and our special projects, is to address as many individual and systemic needs as possible. Currently the special projects CLASSIC has includes Project ID and Community Legal Education

Using lessons learned during COVID-19, CLASSIC moved to hybrid models of provision of services to give community members more options. Providing service in more ways and changing our student model resulted in an 11.2% overall increase in clients served through our full legal representation clinic, the WAC.

## **Special Projects**

#### **Project ID**

Having identification is a basic starter for many aspects of life. Through community consultations, CLASSIC identified the need for many community members to obtain ID. From there "Project ID" was born. **102** individuals obtained ID through our clinics in 2022-2023.

### **Community Legal Education**

CLASSIC provides Community Legal Education in areas of law we are experts in, which are not served through our friends at PLEA. This year CLASSIC hosted:

- 4 PBSC Student Volunteers
- 1 Training Session for students
- 12 Community Legal Education
  Presentations to **137** participants

## ADDRESSING SYSTEMIC BARRIERS (CONT'D)

### Cases, Appeals and Judicial Reviews

Examples of systemic work through cases, appeals and judicial reviews this past year include, but are not limited to:

#### Office of Residential Tenancies (ORT)

- advocating at Court of King's Bench to develop a fulsome test of what is "just and equitable" for a landlord's
  actions,
- advocating for adherence to procedural fairness by the ORT regarding:
  - o challenging rehearing process when someone misses their hearing,
  - in-person hearings vs. over the phone and making both available in addition to providing information about both options,
  - o allowing individuals to physically file evidence vs. only going through the online portal,
  - o challenging barriers to appealing decisions from hearings,
  - o access and usage of the online portal,
- · advocacy around the publication of names with results of hearing, and
- the ORT has the jurisdiction to consider and apply the Human Rights Code.

#### **Immigration**

- · advocating for procedural fairness regarding refugee claims in Canada, and
- advocacy around consideration of the definition of spouse for spousal sponsorship.

#### Ministry of Social Services

- advocacy around what the Government interprets to be "net income" with respect to CERB and challenging how child support is considered by Income Assistance,
- · advocating for consideration of human rights in Income Assistance matters, and
- Advocating around general requirements of procedural fairness through the decision making processes in the Ministry of Social Services, and subsequent appeals.

#### **Prison**

- advocacy around:
  - access to medication and opioid antagonist therapy,
  - o lack of therapy and counselling for individuals, and
  - procedural fairness in general.
